



Client Ads Management Agreement

This Agreement takes effect on date of signing, and continues in force unless specified or terminated.

Services : During the Term of this Agreement, Service provider will provide on going management of Facebook Ads.

The Client gives RS Digital Marketing Agency the complete right to create, adjust and increase Ad spend to grow and scale the Clients campaign (Any specific Ad Spend budget per month) must be confirmed to RS Digital Marketing Agency prior to signing of this contract.

The Client must not adjust or alter the Advertising campaigns unless previous discussed and approved by RS Digital Marketing.

All Advertisements are performed on a month to month basis, this period starts from when the Advertisements go live.

Payment for services : Price. Service Provider shall perform the Services for [\$1650 AUD] per month OR 5% of Revenue Generated (Which ever is the greater)

Payment Agreement. Service provider shall invoice the Client monthly following the previous Months sales. The Payment is due within 2 days of issue each month following the previous months sales. RS Digital Marketing Agency will evaluate sales as per our Data to calculate the monthly sales. Therefore RS Digital Marketing will Invoice the Client \$1,650 AUD or 5% of the Revenue generated from the campaign within the last 4 weeks (Which ever is the greater)

RS Digital Marketing Agency may require additional details and or clarification of revenue generated during this or a set period and would require the Clients full cooperation and assistance with such a matter. If Client does not assist in this transparency of Revenue figures then the Client gives the Service Provider the rights to Pause all Ads awaiting these details/payment. The Service Provider has the rights to terminate the contract if payment is with held and remove all such work created by RS Digital Marketing Agency. All pricing stated in AUD & inclusive of GST

Termination : Either party may terminate this Agreement with or without cause by giving the other party one (1) calendar month's written notice of termination.

The RS Digital Marketing Agency has the rights to remove any of the related campaigns created during its contracted period prior to termination of the contract. All Ad campaigns and material created by RS Digital Marketing Agency remain the sole rights of RS Digital Marketing Agency therefore on the termination of the contract the Client gives the rights to the removal of these from the Facebook Ad account and related material including funnels if RS Digital Marketing Agency require. Any work created by RS Digital Marketing Agency remains theres unless specified or written permission granted.

The Service provider under No circumstances will be held liable for loss, damage or delay of Client’s project.

Renewal. This Agreement may be renewed or extended, and will stay in affect until either party notifies changes.
