





Emerges




Health of Nurses, Health of Workplaces

- Downsizing → Workload
- Nursing shortage...acute in some clinical areas
- Growing absenteeism
- Dissatisfaction and low morale
- Increased ratio of part-time and casual employment
- Reduced access for patients
- Recruitment and retention

Knowledge Development requires critical thinking


- Between 1995 and 1998, an international panel of expert nurses from nine countries: Brazil, Canada, England, Iceland, Japan, Korea, Netherlands, Thailand, and 23 states in the U.S. participated in a study to examine **critical thinking** in nursing .


What do we know ?

- *IANS, Hospital Authority reports, International Labour Force Surveys*
- Research is needed . . .
- . . . but it is just as necessary to make messages about existing results accessible and compelling
- Created broad-based awareness of critical pieces of information (tight, succinct, repeatable, emotionally engaging facts, such as absenteeism statistics)

Knowledge Development & Research




Verify information in as many ways as possible, and with as many stakeholders as possible

- *What are your Universities researching?*
- *What is international research telling us? International Study of Hospital Outcomes*
- *Synthesis Paper*

Public Awareness




Broad-based awareness

Political Engagement




Person-to-person contact (right target, right contact, right route)

- Customize the message
- *Initiate the ripple effect*
- Encourage other complementary initiatives...
- Connect those with interest, information, passion and/or influence regarding the topic
- Professional nursing organizations,



Building the Policy Agenda

Interest Group Activation




Exploit every opportunity to repeat the message . . . build the ripples to a *tidal wave*

- Direct mail from office
 - “Here is the basic message . . . please spread and respond”
 - Invitation to send input regarding activities happening on the ground
- Publications
 - Newsletters
 - Columns in other nursing and health publications (regular & special request)



Building the Policy Agenda

Interest Group Activation




- Word of Mouth
- Speeches
- Visits, interviews
- Formal and informal gatherings/meetings
- Bring people together (*National Stakeholder Consultation Meeting*)
- Proceedings of Meeting . . . send out drafts, invite input, share results
- Engage professional nursing organizations.

Public Policy Deliberation & Adoption




This is where we are now

- The issue is on public and government agendas
- Ministers' Meeting
- *Part of Hospital Authorities Annual Plan- incorporated in 5 strategic directions.*
- *Part of Health Services Accreditation or Certification*



Building the Policy Agenda

Regulation,
Experience,
& Revision



- Policy becomes law
- Issue becomes a new value or “norm” in the culture, and is experienced and revised
- Cycle repeats constantly
- . . . until the next issue comes along

Policy Entrepreneur

Without the presence of an entrepreneur, the linking of the streams many not come together.

- Good ideas lie fallow for lack of an advocate.
- Problems are unsolved for lack of a solution.
- Political events are not capitalized for the lack of inventive and developed proposals.

Policy entrepreneur

“They bring several key resources into the fray: their claims to a hearing, their political connections and negotiating skills, and their sheer persistence. Items’ chances of moving up on an agenda are enhanced considerably by the presence of a skilful entrepreneur ” John W. Kingdon, 1995



Nurses as Policy Entrepreneurs

- 'Surfers' of policy domain - watching the waves and watching the time
- Exhibit a wide horizon of choice
- Coupling and softening-up processes
- Create agenda items
- Create linkages & couplings - problems, policy and political streams
- Engaging and constantly responding to change
