Your application will be juried by a committee that is looking for unique items. We want fresh ideas, not a rehash of the booths we already have.

Application & Cancellation Policy

1. **Applications must be postmarked by October 1st. Those mailed after that date will not be accepted.**
2. If you have sold your business the new owner must apply as a **new vendor**. A space will not be guaranteed.
3. Subletting or sharing of space is not permitted without approval of the fair management. In the event the vendor shall not occupy said space, the Festival reserves the right to occupy or cause to be occupied such space, with no refund or allotment to vendor. If said space is re-assigned to another vendor, the new assignee will be given priority for that space the following year.
4. In the event that a vendor cancels or is otherwise unable to attend the Festival, it will be the vendor's responsibility to contact the Festival Committee for an application if they wish to apply for the following year.
5. If accepted, cancellations must be made in writing. Cancellation 90 days or closer to show date will result in forfeiture of all fees. Any cancellations must reapply as a new vendor. Failure to notify Maryland Sheep and Wool festival of cancellation jeopardizes participation in future events.
