

Notice for Open Tender

Infrastructure Upgrade for the Health Facilities Selected as Maternal and Newborn Centers of Excellence in Turkana County, Kenya

1. The United Nations Office for Project Services – East Africa Hub (UNOPS- EAH) is undertaking the Infrastructure Upgrade for the Health Facilities selected as Maternal and Newborn Centers of Excellence in Turkana County. This project is a part of the DFID funded Health Systems Strengthening Programme implemented in collaboration with UNICEF, the Kenyan Ministry of Health, the Turkana County Health Management Team and is financed by DFID – UK Aid.
2. UNOPS-EAH invites sealed bids from eligible bidders who have a valid NCA (National Construction Authority – Kenya) registration under Building class and having experience in similar nature works for the infrastructure upgrades of Health Facilities (hereinafter called as "Works"), under the terms set forth in the bid documents.
3. The ITB consists of five (05) lots detailed in the Table - 1 below. Bidders at their own discretion may bid for any lots, combination of lots or all the lots, if the proposed amount of works is within their financial limit and capacity. If the bidders are bidding only for one lot the minimum category shall be **C6 or above**. If bidding for more than one bid is **C5 or above**. The award shall be provided for a **maximum of two lots** based on the lowest priced substantially compliant combination, which achieves the best overall value-for-money for UNOPS.
4. Electronic version of the Bid documents of all five Lots can be obtained by interested and eligible bidders from UNOPS website from 25th July 2016

5. All bids must be accompanied by a Bid Security from a reputed bank in the prescribed format addressed to the Director of UNOPS-EAH and shall be valid for 120 calendar days from the date of bid closure. The amounts of Bid Security for each Lot shall be in accordance with the Table-1 below and if a bidder is bidding for more than one Lot, he shall obtain the Bid security for the total of bid securities of the Lots that the bidder is bidding.

6. Bid must be received by UNOPS through the email account/address specified the tender documents by the bid receipt deadline. Bids sent to any other physical / email address will be declared invalid.
7. Please be advised that UNOPS reserves the right to amend the solicitation documents at any time. Any amendments or clarifications will be posted under the "View documents" of the concerned case file on the "Business opportunities" on www.unops.org, and we kindly ask you to check the site before submitting your bid.
8. Sealed envelopes shall be delivered, in accordance with the Instructions to Bidders, on or before 12.00 noon (Kenya Time) on 17th August 2016. Bids will be opened at 3.00pm (Kenya time) on the same day at UNOPS-EAH Head office, at UN lane, off UN Avenue, next to Warwick center, Nairobi, Kenya. Bidders or their authorized representatives may be present at the opening of bids as witnesses. Bids received after the stipulated closing time will be rejected and returned unopened. Bid opening schedule will be submitted to Turkana County Health Management Team on 18th August 2016 in order to display it on the public notice board – Turkana County Health Ministry.
9. A mandatory clarification meeting will be held on 2nd August 2016 at St.Teresa's Pastoral Center located in Lodwar to clarify any matters pertaining to this bid. Mandatory field visit will be conducted on 2nd, 3rd & 4th August 2016 as scheduled in bid document.
10. UNOPS-EAH will not be responsible for any costs or expenses incurred by bidders in connection with the preparation and/or delivery of bids.
11. For companies not registered with the UN Global Marketplace (UNGM), it is mandatory to do so in order to be able to do business with UNOPS.
