RECOMMENDATION

Selection of one firm and an alternate to provide Continuing Professional Consulting Services for Construction Engineering and Inspection (CEI) Services for Construction Projects with Local Agency Program (LAP) Funding, Request for Proposals Y16-906-CH, from the following firms, listed alphabetically. Further recommend the Board authorize negotiation and execution of the final contract by the Procurement Division to establish hourly rates for future requirements. The performance period for the contract will be for 3 years with two 1-year renewals.

AECOM Technical Services, Inc.
CDM Smith, Inc.

This item was evaluated by the Procurement Committee on August 3, 2016. Commissioner S. Scott Boyd was assigned to the Procurement Committee.

PURPOSE

The consultant will provide project management and support services to oversee the construction of a variety of County transportation and roadway construction projects. Services will include engineering and inspection services, coordination with contractors, shop drawing reviews, evaluation and negotiation of change orders, and review of pay requests. The County will be reimbursed for the costs of services procured under the contract with federal funds through FDOT.

DISCUSSION

Four proposals were received in response to the solicitation. The proposals of Carnahan Proctor and Cross, Inc. and DRMP, Inc. scored too low for Board consideration.

The consensus score of the Procurement Committee is attached.
