I acknowledge and agree that my coaching will begin the month indicated in the box above or the month this Agreement is received by KWRI (whichever is sooner) and will continue for six or twelve consecutive months thereafter, depending on the product selection above. I agree that this Agreement will automatically renew for successive six-month or twelve-month terms unless I provide written notification of termination of my participation at least 30 days in advance of the semi-annual or annual renewal date. If I provide written notification of my termination of participation, I understand and agree that I must obtain written confirmation from KWRI acknowledging receipt. I authorize KWRI, or its designee, to charge my credit card for coaching services that I receive. I agree that a payment will be charged as soon as this Agreement is received and that additional payments will be charged to my credit card on a monthly basis thereafter during the initial six-month or twelve-month term and any renewal terms of this Agreement. If payment is not received within 30 days of a due date, coaching calls will be suspended until payment is received. This authority remains in full force and effect throughout the term of this Agreement, including any renewal terms. I will have the above-prescribed number of calls, each call for the duration of thirty minutes. I am committing to a six-month term or a twelve-month term by signing this contract, *a covenant commitment*. I will be charged for missed calls; it is my responsibility to notify my coach of any calls I will miss at least two days prior to the day of the call and to work with my coach to reschedule that call. I will be charged for a missed call without opportunity to make up that call if I fail to notify my coach within the time period set forth above. I understand that my coach may not be available for coaching every week due to other commitments (e.g. vacations, holidays, conferences, etc.) and will work with my coach to reschedule calls as necessary. Your personally identifiable information provided herein will not be shared in ways or for reasons unrelated to the ones herein without your prior written consent. I acknowledge and agree that calls may be recorded for training purposes only. By providing my cellphone number, I expressly opt-in to receive text messages from KWRI, or its designee, either directly or via a third-party service.
