

## Donation agreement

Kazan city

Citizen of the Russian Federation,

hereinafter referred to as "Endower", on the one hand, and

**Autonomous non-profit educational organization "International School of Kazan"**, hereinafter referred to as "School", represented by its principal Gafiatullin Niyaz Mansurovich, acting upon the Charter, on the other hand,

together hereinafter referred to as "Parties", have entered into this agreement as follows:

## 1. Subject of the agreement

1. In accordance with the terms of the present agreement, the Endower transfers free of charge, and School accepts monetary funds for purposes, specified in paragraph 1.2. of the present agreement.
2. Donation is transferred by the endower to the School for intended use in accordance with Regulations on procedure of fund-raising, expenditure and accounting of donations made by physical persons and legal entities, approved by the decision of the School Founder of "\_\_\_\_\_" \_\_\_\_\_ 201\_\_\_\_ and the School Charter.

## 2. Procedure for granting and expenditure of donations

1. The total amount of donation according the present agreement is \_\_\_\_\_ (\_\_\_\_\_) rubles and is transferred to the School without any obligation to refund the above-mentioned sum.
2. Endower transfers donation as a one-time payment in full amount to the School current account, specified in paragraph 4 of the present agreement on the day of conclusion of the present agreement.
3. The school undertakes to use the funds strictly for its intended purpose.
4. The school maintains a separate record of all operations on the use of donations.

### 3. Final provisions

1. The present agreement shall come into effect from the moment of its signing by the Parties and shall remain in force until obligations of the Parties implied by provisions of the present agreement have been fulfilled.
2. The School has a right to refuse from donation at any time prior its transfer. In this case the agreement shall be deemed terminated.
3. All disputes and disagreements that may arise between the Parties shall be settled by negotiation on the basis of existing legislation. When a failure in

the process of negotiating the contentious issues, the dispute shall be settled judicially in accordance with the current legislation of the Russian Federation.

4. In everything not covered by this Agreement the Parties shall govern by the current legislation of the Russian Federation.

5. The terms of the present agreement and supplementary agreements thereto, are confidential and cannot be disclosed.

6. All changes and additions to the present agreement must be made in writing and signed by authorized representatives of the parties.

7. The present agreement is executed in two counterparts of equal legal force, one for each of the Parties.
