Customer furnishes all fuel and lubricants during rental period.</li> <li>4. Fill fuel tank to full level before machine return.</li> <li>5. Rental starts when machine is picked up or delivered.</li> <li>6. Rental stops when equipment is returned to Deer Mountain Equipment or when DME is notified to pick up rental machine.
