Nvisionate LLC (lessor) has leased to the above mentioned client (lessee) the vehicle listed above for their upcoming production. The lessee will furnish fuel, oil and maintenance while the equipment is in their possession as well as assume full responsibility for all risk of loss and/or damage to the lessor's equipment from whatever cause during this agreement, or before redelivery to lessor and will indemnify the lessor for any loss or damage to said equipment, unless such loss/damage is caused by sole negligence of lessor. Lessee is responsible for ensuring all drivers of vehicle are licensed drivers and are employees of the lessee. Vehicle must be returned with gas tank full, or \$75 additional charge will be due. If vehicle is returned late, an overtime rate of \$25/hour will be due. A GPS tracking device as well as front and rear cameras are installed on all vehicles, and must not be disabled or tampered with at any time.

As provided under the terms of this lease agreement, the lessee shall indemnify and hold harmless the lessor and/or all affiliated companies and members of such from each and all of the following:

1. Any and all liabilities, claims, damages, costs, expenses, and lawsuits arising from any action during the lessee's rental of such equipment;
2. Any injuries sustained or incurred by any cast, crew, or employee(s) of the lessee and/or the production company;
3. Any liabilities, claims, expenses, and lawsuits from lost and/or postponed production time as a result of loss of use of the lessor's equipment.

If for any reason, damages occur during Lessee's possession of said equipment, Lessor will notify Lessee of damages and cost to repair equipment as soon as possible. Lessor expects payment for damages within 48 hours, which will include daily rental charges until the repairs have been completed (up to a maximum of 21 days). If vehicle is impounded, lessee is responsible for all fees and rental charges until vehicle is back in possession of lessor.

The lessee shall provide NVISIONATE LLC with a CERTIFICATE OF INSURANCE for Liability and Comprehensive coverage with the following requirements on all equipment of not less than: \$1,000,000 / \$1,000,000 Bodily Injury Liability AND \$1,000,000 / \$1,000,000 Property Damage Liability OR \$1,000,000 / \$1,000,000 Combined Single Limit Bodily Injury/Property Damage Liability

Above required insurance is to be verified by filing a Certificate of Insurance containing the following:

1. Include NVISIONATE LLC @ 2015 N. Lincoln St, Burbank, CA 91504 as additional insured under Lessee's Automotive Liability and Comprehensive and General Liability policies, and name Lessor as Loss Payee under Lessee's Comprehensive and Collision Policies
2. Provide a 10 day notice of cancellation or deduction of insurance coverage to NVISIONATE LLC
3. Contain a statement that the lessee's insurance is primary with respect to NVISIONATE LLC over all other insurance.

POLICE VEHICLE RULES

Police appearance vehicles have VERY strict laws and regulations in place. Failure to follow the rules below, **MAY RESULT IN YOUR ARREST and/or MAJOR FINES!!** Renting and driving one of these vehicles is an enormous responsibility not to be taken lightly. You are not only liable as the producer signing this agreement, but are required to notify all cast & crew members who will use the vehicle of these rules, for their own safety. An actor or crew member who you place in this vehicle and who is not notified of the rules, will still be in jeopardy of arrest or fines for breaking them!! If you or your crew are uncomfortable transporting the vehicle to and from set, please make arrangements to have it towed on a flat-bed truck.

- 1. Lightbar Cover, "Out of Service" Signs, and Prop License Plates**
 When not on a closed film set, the black lightbar cover must fully cover the roof lightbar so that no red or blue lights are visible, the magnetic "Out of Service" signs MUST be attached on 3 sides of vehicle, and the official DMV license plates must be on the vehicle at all times. This includes while parked on public streets or parking lots. The magnetic signs must cover the police logo on driver and passenger side doors, and on the rear of the trunk.
- 2. Police Lights and Siren May Not Be Used At Any Time Unless On Private Property or Closed Film Set**
 The display of red or blue lights, or turning on the siren on any public road (even while parked) may constitute impersonating a police officer. This is not a toy to "prank" someone, even if you think it's just for 10 seconds. Turning them on even for a second while not on a closed film set could be considered a felony.
- 3. Possibility of Being Confused for Real Police Officer**
 It is possible that, even while following the rules above, you may be approached by a citizen requesting help in an emergency. They may not see or understand the "Out of Service" sign. At no time may the occupants of the vehicle present themselves as a law enforcement officer or first responder. You must immediately inform them that this is a film production prop car, that you are not a police officer or employee of a police department, and that they must call 911 for assistance.
- 4. Professionalism While Using Vehicle**
 It is important to remember that while driving this vehicle, even with "Out of Service" signs present, you will still appear to be representing a police department to many people. Please act and dress professionally while operating the vehicle. Failure to do so will certainly attract unwanted attention, not to mention portray law enforcement officers and the police department marked on the vehicle in a bad light.
- 5. If Pulled Over Or Approached By Police Officer**
 If you are approached by, or pulled over by a police officer, immediately inform them that this is a prop vehicle used for film production, and show them your rental agreement and film production documents or permit. Remember to be professional, courteous, and provide all necessary information to them to show this is a legitimate production vehicle and usage of that vehicle.
