The Fond du Lac County Purchasing Department will be accepting quotations for the furnishing and installation of a metal roof system on the Restroom/Shower building located at Columbia County Park (located at Pipe Village Hwy 151 North. Contractors are required to attend a pre-bid meeting on June 26th at 10:00 am at the building site. The County will not be responsible for incorrect assumptions or mistakes in the quote made by contractors not inspecting the work or confirming information provided at the meeting.

Scope of work will include: removal and disposal of existing cedar shake shingles, felt and eave metal; installation of ice and water felt at roof perimeter, 15# felt on balance of roof; furnish materials & labor for installation of new 24 ga. pre-finished metal 18+on center double lock standing seam metal roof system with flashing, trim and new fascia; any required site restoration and clean up. There will be an alternate site roofing job (pit toilet bldg.) discussed at the meeting. It is understood and agreed that the basis for award of this work will be the Total Price Quote for the roof and all materials and labor required to perform the work. The Contractor is expected to anticipate the usual and customary costs and expense in doing the work and will not hold the County liable for any typical work required but not stated in this Request For Quote.

Contractors submitting a quotation for this project must be able to provide a Certificate of Insurance to the County which will hold the County harmless for all liability for damages caused by the performance of the work. The Contractor shall not commence work until such time as the County has received certificates for Workmen's Compensation, Comprehensive General Liability and Property Damage and Comprehensive Automobile Liability and Property Damage.

Quotations shall be delivered or mailed to Linda G Chandler, Fond du Lac County Purchasing Office, 160 S. Macy Street, Fond du Lac, WI 54935 by 2:00 p.m. on June 28th at which time they will be opened and read aloud. Please clearly mark "**Roofing Quotations**" on the envelope.

Fond du Lac County reserves the right to reject any and all quotations and the right to disregard any and all nonconforming quotes. The County will award the work to the firm based upon their quotation which will best serve the interests of Fond du Lac County.
