Client assumes all responsibility for obtaining and retaining permission for access to any requested camera positions and is solely responsible for the quality of the final production resulting from the use of, or inability to use, such camera positions.
- 3. Brian Kirby reserves the right to use videos for display, publication or other purposes. All video masters and raw footage remain the exclusive property of Brian Kirby.
- 4. The client reserves the right to terminate the contract for any reason at any time up to the date of the event. Should the client terminate the contract, all money paid less the Deposit will be refunded.
- 5. If Brian Kirby fails to comply with the terms of this agreement due to any event or at beyond the control of Brian Kirby, including but not limited to illness, accident, labor disputes, acts of God and other catastrophes, or uncontrollable and unforeseeable equipment failure, Brian Kirby liability is limited only to a refund of all monies received.
