**D. ELABORATION OF SCOPE**

**1. General :**

Furnish all labor, material, plant, equipment, and miscellaneous accessories, required to construct complete form, place, pump and finish all Concrete work as shown on the Contract Drawings and described in the Contract Specifications, for a complete finished product. Concrete work shall include pumps, labor for spread footers and slab on grade for the complete construction of **The Historical Restoration and Renovation to the Historical Jefferson County High School.** No masonry is included in this agreement.

**2. Description of Work:**

The following Specification Sections, hereby identified, and other items of work described herein and by other documents define the scope of work for this Bid Package. Furnish and install the building components identified by these Specification Sections and clarified by the balance of paragraph "D" of this Bid Proposal Form.

- a. Clarification of work included. The work of this Bid Package includes, but is not limited to, the following:

- 1) Provide all labor, material, plant and equipment required. See specifications for details.
- 2) **ALT #2-** Provide all labor and materials to furnish to form, place and pour Concrete for the southeast corner on the east basement. To patch and infill wall below grade where old stair case was removed and infilled improperly. Back fill with compact fill and reform and pour back side wall.
- 3) **ALT #3-** Provide all labor and materials to furnish and remove Concrete flooring in east basement outside of elevator pit. See page A101 on the Architectural plans for details to all Alternates.
- 4) Furnish, install, and maintain all hoisting required for the construction of the building components included in this Bid Package.
- 5) Remove from the building site, including the legal disposal of, all trash, debris, and spoil resulting from this work. Dumpster provided by GC.
