Conditions of Sale:

1. Each family (not per exhibitor) is required to contact five potential buyers and submit their names and addresses to the Extension Office by the required date. Please print complete, accurate, readable names and addresses for potential buyers. We must be able to read names and addresses for future mailings.
2. A fee of 3% on sale price will be deducted from the sellers check at the Sale to cover sale expenses.
3. 4-H members must be in good standing with their club and completed their livestock, bacon or ham project; FFA members must be members in good standing of a FFA Chapter.
4. Only Audrain 4-H (age 18 years and under on December 31, 2017) and FFA members (age 21 years and under on December 31, 2018) who have completed the particular project (ham, sheep, goat, rabbit, beef, swine or poultry) are eligible to participate.
5. To qualify to sell, steer, market heifer and market hogs must have been weighed in, all livestock, bacons and hams must have been shown at the Audrain County 4-H and Youth Fair.
6. In order to retain the right to exhibit at the Missouri State Fair the member must have a signed contract between buyer and seller prior to collecting the sell proceeds. Forms are available in the Extension Office.
7. The seller will refund full purchase price to the buyer should a bacon or ham not be edible.
8. All animals/bacons/hams to be sold must be in place by 1:00 p.m. sale day. Failure to be on time will result in an automatic forfeiture of 25% of sale premium.
