## College Scholarship Program - Exclusively for First Credit Union Members

Education is a positive step towards a brighter future. First Credit Union is committed to education and life-long learning. Our College Scholarship Program, available exclusively to First Credit Union members, recognizes and rewards graduating high school seniors on the path to higher education with a \$1,000 scholarship to use towards a full-time course of study at a Arizona university, college, or vocational school. First Credit Union will award up to three (3) \$1,000 scholarships in 2020. Complete program details including eligibility and requirements are below.

## Eligibility

Scholarship applicants must meet all of the following requirements:

- Be a primary member of First Credit Union and in good standing when scholarship application is submitted (*Please be aware volunteers, employees of First Credit Union, and their immediate family are NOT eligible to apply*)
- Be a 2020 graduating Arizona high school senior
- Plan to enroll, beginning the fall of 2020, in a full-time course of study at an accredited two- or four-year university college, or vocational school in Arizona (*Full-time is the equivalent of at least 12 credit hours or as otherwise defined by the school*)
- Be a United States citizen

## Requirements

Applicants must submit all of the following:

- Completed application
- High school transcript - minimum cumulative GPA of 2.5 required
- Essay regarding "What Being a Member of First Credit Union Means to Me"
  - ~ Include name and address on essay
  - ~ Essay should be 500 words or less, double-spaced, and typed or printed
- Letter of recommendation from one (1) counselor, teacher or other school official
- Complete young adult online survey. Survey link is available @ [firstcu.net/community](https://firstcu.net/community).

## Process

Complete applications received on or before deadline will be considered by a panel of judges comprised of First Credit Union staff employees and executive management. Applications will be judged on academic achievement, letter of recommendation, and essay. Essay and letter of recommendation will be judged on spirit, content, and quality. Course selection and GPA will be the basis for academic achievement consideration. Survey responses will NOT be considered during evaluation process.

## Important Information

Please send completed application and corresponding materials to the address below postmarked no later than February 14, 2020. Late or incomplete applications will not be considered. All decisions are final. Recipients will be notified via email by March 27, 2020. Scholarship funds will be deposited into each recipient's First Credit Union savings account no later than May 15, 2020.

In order to receive the scholarship, recipients must plan to enroll in an accredited two- or four-year university, college, or vocational school in the fall semester following their high school graduation. Scholarship funds will be deposited directly into recipient's First Credit Union savings account no later than May 15, 2020.

## Conditions

**Each recipient is subject to the following conditions:** Recipient must sign all required legal documents provided by First Credit Union, verifying and guaranteeing the work submitted is an original, unpublished essay authored by said recipient. Any essay found to be, in any way, reproduced or copied from an existing work will immediately be disqualified.
