

Parent/Legal Guardian Agreement to Study Form

To be completed by the parent or legal guardian of a student under the age of 18.

King's College London has a particular duty to protect children under 18 who apply or are admitted to the university. Under English law, a "child" is legally a person under the age of 18.

As the parent or legal guardian of a student who will be under the age of 18 at the time of enrolment, you are required to read the [Guide to Supporting Students under the Age of 18](#) and complete this agreement form.

It is important that this form is completed by you, the parent or legal guardian, but if necessary please talk through the form with the student as you complete it.

Please be aware that a delay in filling out this form can delay your child receiving the Confirmation of Acceptance for Studies that he or she needs for a visa to study in the UK.

Accommodation

I accept that, except in an emergency, King's College London will not disclose confidential information (for example, about a student's academic progress) to a parent, legal guardian, UK-based educational guardian or anyone else without the consent of the student.
