EXAM DAY RULES AND GUIDELINES:

- Students may begin arriving as early as 8:15 a.m. Students arriving past 9:15 a.m. **will not be admitted** to the testing area and will have to reschedule.
- **All students must present a current school or government issued picture ID.**
- All personal items must be placed in lockers. Students will be given a key to secure their items in a locker.
- Students must remove all watches, Fitbits, listening and recording devices from their person and place them in a locker.
- Students must remove all hats and head coverings unless they are worn for religious or medical reasons. Regardless of the reason for headwear allowance, a student's ears must be shown to a testing administrator, in a private setting, to ensure that no recording or listening devices are present.
- Children will not be allowed in the testing area.
- Students will not be permitted to bring a cell phone into the testing area – NO EXCEPTIONS.

CREATING YOUR LOGIN ACCOUNT:

- All students will be required to create a login account with a username and password.
- Instructions on how to create that account will be sent in a reminder email a week prior to the student's exam.
- In order to create an account, students **MUST** have a valid **HCC email address**. After completing the exam, a student receiving a score of less than 70 will have a remediation packet (review material) sent to their HCC email by the testing company.

WHAT TO EXPECT DURING THE EXAM:

- Students will be given a maximum of 5 hours to take the exam.
(*New for LPN Applicants for Fall 2019: All students will be required to take the chemistry component of the exam.*)
- Water and bathroom breaks are allowed during the exam, however, the clock for the exam will not be stopped.
- Students will receive an official score report at the completion of their exam. If a student has questions pertaining to their score, Nursing Advisors will be available in the Office of Admissions & Advising (RCF-242).

STUDY MATERIALS:

- **HESI Admission Assessment Exam Review, 4th Edition**, is available for purchase at the HCC Bookstore. The study guide is also available to view at the Clark Library here on campus. If you choose to use the study guide, please disregard the section covering Physics; this topic will not be required on your exam.

EXAM BREAKDOWN:

- Math: 50 questions covering multiplication, division, addition, subtraction, fractions, ratios, proportions, decimals, conversions, household measures, roman numerals and dosage calculations.
- Reading Comprehension: 47 questions assessing your skill in understanding reading passages – identifying main idea/theme, determining meaning of words and phrases in context and understanding passages and making logical inferences.
- Vocabulary: 50 questions assessing your knowledge of various health care related vocabulary.
- Grammar: 50 questions assessing your skill in basic grammar principles – understanding important terms and their uses in grammar, parts of speech and common grammatical errors.
- Chemistry: 25 questions covering atomic structure, periodic table, matter, chemical equations, chemical reactions, chemical bonding and nuclear chemistry.
- Anatomy & Physiology: 25 questions covering anatomical structures, systems and general terminology.
- Biology: 25 questions covering photosynthesis, metabolism, cells, cellular respiration, biology basics and biological molecules.
