Material facts must be disclosed in relation to yourself and all other persons who are to be insured. If you are in any doubt as to whether a fact is material then it should be disclosed to Whittams Hire. It is an offence under the 'Road Traffic Act' to make any false statement or withhold any material information for the purpose of obtaining a certificate of motor insurance. If any changes in circumstances arise during the period of insurance cover please advise Whittams Hire with details. A specimen copy of the policy wording is available on request.

**PLEASE NOTE**

The vehicle must be returned undamaged with the same amount of fuel supplied at handover. You must, prior to return, empty the waste water, empty the toilet cassette and ensure the interior is clean to the same condition when supplied. Failure to do these things will result in charges (as shown). Also, if carrying pets on board, the vehicle must be valeted prior to its return. There is strictly no smoking allowed in the vehicle, including tobacco & vaping products. All hirers/drivers are liable for their own penalty points and fines for any offence picked up during the hire period.
