This agreement of Pine Ridge Golf Club and Ridge Rib and Steakhouse to perform shall be excused by acts of God, or any other legitimate condition beyond their control. If such circumstances arise, all reasonable efforts will be made to find comparable replacement event planning at the agreed upon fees. In the event of non-payment, Pine Ridge Golf Club retains the right to attempt collection through all legal and permissible means. Client will be responsible for all court fees, legal fees, and collection costs incurred by Pine Ridge Golf Club and Ridge Rib and Steakhouse

It is further agreed to and understood that Client shall be charged \$50 for each returned check charge for each collection notice.

It is agreed that Client will take reasonable steps to protect Pine Ridge Golf Club personnel and equipment during the contracted period. In the event of injuries or damages resulting from insufficient protection on Client's part the Client will be responsible for

paying for all of Pine Ridge Golf Club and Ridge Rib and Steakhouses resulting costs (including, but not limited to, insurance deductibles, medical treatment) that are not reimbursed by insurance.

It is agreed that there will be no children on site after 9 p.m. and that all children on the grounds prior will have an adult with them at all times and is agreed that children will not be permitted outside playing on any part of the grounds. Client also agrees to allow Pine Ridge Golf Club to have consent to take photos to use for marketing purposes.

This agreement cannot be canceled except by mutual written consent of both the Client and Pine Ridge Golf Club and Ridge Rib and Steakhouse. If cancellation is initiated by the Client in writing and agreed to by Pine Ridge Golf Club and Ridge Rib and Steakhouse in writing,

Client will be required to pay any unrecoverable costs already incurred by Pine Ridge Golf Club and Ridge Rib and Steakhouse (but not more than the total fee agreed upon).

It is hereby agreed and understood that the laws of Minnesota State shall govern this agreement.

Client agrees to defend, indemnify, assume liability for and hold Pine Ridge Golf Club harmless from any and all claims, demands, damages, losses, suits, proceedings, penalties, expenses or other liabilities including attorney fees and court costs, arising out of or resulting from the performance of this contract, regardless of the basis (except for gross negligence on the part of Pine Ridge Golf Club and Ridge Rib and Steakhouse. This agreement is not binding until received and signed by Pine Ridge Golf Club and Ridge Rib and Steakhouse. Any changes must be written and signed by both the Client and Pine Ridge Golf Club. Oral agreements are non-binding. The latest contract supersedes all previous contracts between Client and Pine Ridge Golf Club for the event listed above. If any clause in this Agreement is found to be unenforceable by a court of law, the rest of this Agreement shall remain in full force and effect. This Agreement may be executed in multiple counterparts, and each such executed counterpart shall be deemed an original, but all of which together shall constitute a single agreement. Pine Ridge Golf Club and Ridge Rib and Steakhouse may elect not to exercise rights specified in this agreement. By doing so, Pine Ridge Golf Club and Ridge Rib and Steakhouse does not waive their right to exercise those rights at a future date. In the event that there is an unpaid balance thirty (30) days after the event, there will be interest charges on the unpaid balance at a rate of 3% per month.
