Representing \_\_\_\_\_, Client, hereinafter designated as Client, do hereby agree to the following terms and compensation to be paid to, REXData.

1. Compensation shall be paid on all transactions completed with Prospects introduced as identified in this Agreement for a period of five(5) years from the first date that Prospect was introduced to Client. Prospects may be either a Buyer or Seller.
  - (a) Commercial and Income Properties (greater than four units): 3% of the 1st \$500,000, 1.5% of the balance over \$500,000.
  - (b) Vacant Parcels, Vacant Ranches and Development Land: 5% of the 1st \$500,000, 2.5% of the balance over \$500,000.
  - (c) Residential (1-4 units), Agricultural and Ranches with Residence, 3% of the 1st \$500,000, 1.5% of the balance over \$500,000.
  - (d) Option: Client agrees further to pay REXData, as compensation for obtaining an option, a fee of 4% of the option amount.
  - (e) Real Estate Agents or Brokers acting as Agents or Brokers: 20% of the gross compensation received by Broker.
2. Compensation based on this agreement are due to REXData upon recordation of deed or other evidence of transfer.
3. Upon acceptance and receipt of this agreement REXData, will use its best efforts, on a non-exclusive basis, to provide Names, Addresses and Telephone numbers, of Prospects, from time to time, in writing, FAX or Email to Client. Client agrees to hold in strict confidence all information provided, and will interpret this data broadly, to give the full effect as to its intent, and not narrowly, in order to avoid its intent.
