## CAR PARKING AGREEMENT - SHORT AND LONG TERM

### A. Object Purpose

A.1 Europarking rents to the client, while in the same way the client rents from the Europarking, the parking space, for a period of: \_\_\_\_\_ for a rent of: € \_\_\_\_\_ included VAT. This space forms part of Europarking. hereinafter "the premises".

A.2 The premises may only be used as parking space for the car of the following description: Mark & Type \_\_\_\_\_

Licensed Plate: \_\_\_\_\_, hereinafter "the vehicle".

A.3 By signing this agreement the client declares to be the owner of the vehicle as described in A.2.

A.4 The vehicle is asset of the client. EuroParking will use the car at the request of the Client only for transportation from location of collection (G.2) and for transportation to the location of delivery (G.3).

### B. Duration, extension and termination

B.1 The client rents the premises as of: \_\_\_\_\_ Until: \_\_\_\_\_

B.2 The parking agreement will automatically end on the second date as mentioned in B.1, unless extended by the client only.

B.3 Termination of this agreement by the client on an earlier date should be done with due regard for at least one day period notice prior his new return.

### C. Payment obligations and period

C.1 The payment is the compensation for use of the premises, transportation and insurances.

C.2 Payment should be done in accordance with article 8.1 of the General Conditions, **directly when EuroParking is delivering the vehicle to the client** (in case of contract <6 weeks) or in advance (in case of contract >6 weeks) in cash to an employee of EuroParking, without any reduction, adjustment or postponement unless expressly agreed otherwise stating the reference number given in the invoice.

G.3 When the payment is not effected at the moment of delivery of the vehicle, EuroParking is entitled not to deliver the vehicle until the payment is effected. Extra costs for the procedures of delivery on a later moment are the liability of the client.

C.4 EuroParking will be entitled to keep the vehicle in parking in relation to the clients failure to satisfactorily fulfil his obligations of the above mentioned, without being obliged to do so. Until the client has fulfilled his obligations. If EuroParking has to provide longer parking because of the above mentioned, the client has the obligation to pay for the extra costs.

C.5 Compensation for utilities, supplies and services including but not only gas, water and electricity, that may be provided by Europarking for the client, will be charged to the client separately from the rent mentioned in C.1 by EuroParking and will have VAT included.

### D. Applicability of the general Conditions and Rules and Regulations

E.1 The rules and regulations, as determined by EuroParking, also apply to this agreement unless application of the General Conditions is not compatible with the provisions of the Agreement, in which case the provisions in this Agreement will apply. EuroParking declares to have the General Conditions available for the client at any time.

E.2 The client hereby declares that he accepts the applicability of the above-mentioned General Conditions.

### F. Representatives competency

F.1 In signing this parking agreement the client declares in advance that the person who signs, or will sign, any documentation, or makes, or will make any arrangements relating to this rental agreement is competent to do this.

F.2 In continuation of the preceding, the client will never appeal on the

basis of the lack of competence of the representative referred to in article F.1. Furthermore, the parties agree that EuroParking is not obliged to investigate the representative competency of the person acting on behalf of the client.

### G. Collection & Delivery

G.1 The client will leave behind the vehicle closed and secured at the parking of Alicante and will deliver keys of the vehicle to EuroParking on the first date mentioned in B.1 at Alicante.

G.2 EuroParking will leave behind the vehicle, closed and secured at the parking of Alicante and will deliver the keys of the vehicle to the client at the check-in hall of Alicante Airport on the second date as mentioned in B.1 with:

G.4 EuroParking is responsible for the vehicle during transportation from the locations as mentioned in G.1, G.2 and the parking facility, located in Alicante. Fines and penalties laid on by authorities are the full responsibility of EuroParking except in consequence of not meeting the obligations of the client as stated in article H.

### H. Insurance

H.1 The client is obliged to insure the vehicle, except for the transportation by EuroParking. By undersigning the Agreement the client is declares to have a normal vehicle insurance. By understanding this Agreement EuroParking declares to have effected an extra insurance for damages by third parties and theft of parts during parking.

H.2 The client will leave all the documents in the vehicle, which are obliged to have on board by Spanish law whilst driving on a public road.

### I. Vehicle damage & Technical failures

I.1 In signing this Parking Agreement, the client declares in advance that he delivered the vehicle to EuroParking undamaged by choosing "no" below or with unspecified damaged by choosing "yes" below or in addition to a "yes" with the damaged as specified in the appendix (see reserve of this agreement).

I.2 If between the signing of this agreement and the collection of the vehicle by EuroParking, EuroParking discovers any damage on the vehicle, which has not been reported by the client to EuroParking, EuroParking is entitled to end this agreement immediately. In this case EuroParking will try to get in touch with the client as quickly as possible.

I.3 EuroParking does not take any responsibility of consequences due to technical failures of the vehicle.
