## Reference List

### Basics of Reference Listing

1. Reference list only includes those that are cited in-text and are recoverable.
2. The list must be double-spaced.
3. Entries must have hanging indentation and alphabetically arranged.

## In-Text Citations

### Citation Basics

1. Follow the author-date method of in-text citations. For example, (Dessler, 2013).
2. All sources that are cited in the text must appear in the reference list at the end of the paper.

### *Quoting*

If you are directly quoting from a work, you will need to include the author, year of publication, and the page number for the reference (preceded by “p.”).

Examples are:

According to Dessler (2013), “globalization refers to the tendency of firms to extend their sales, ownership, and/or manufacturing to new market abroad” (p.37).

Usually, “globalization refers to the tendency of firms to extend their sales, ownership, and/or manufacturing to new market abroad” (Dessler, 2010, p.37).

If the article you are directly quoting does not have page numbers, identify the number of the paragraph you are directly quoting.

For example:

Usually, “globalization refers to the tendency of firms to extend their sales, ownership, and/or manufacturing to new market abroad” (Dessler, 2010, para.1).

## ***Paraphrasing***

If you are paraphrasing an idea from another work, you only have to make reference to the author and year of publication in your in-text reference. Examples are:

According to Dessler (2013), sales expansion is one reason of companies expanding abroad.

Sales expansion is one reason of companies expanding abroad (Dessler, 2013).

## **Citing author/s**

One Author	(Donatelle, 2013)
2 Authors <i>List both authors</i>	(Kaufman & Schwitters, 2013)
3-6 Authors <i>Cite all authors for the first time in text citation. If you cite that work again you only list the first author and “et al.”</i>	(Barnett, Ziegler, & Byleen, 2011)  <u>Subsequent citations:</u> (Barnett et al., 2011)
7 Author and more <i>List the first author followed by “et. al.”</i>	(Reynolds et al., 2010)
No Author <i>Substitute the title for the author name</i>	(Short title, 2010)
Group as Author <i>List the complete group name for the first time in text citation. If you cite that work again, abbreviate the group author name.</i>	(Canadian University Dubai [CUD], 2015)  <u>Subsequent citations:</u> (CUD, 2015)
No date of publication <i>Use “n.d.” if the date is not found.</i>	(Robbins, n.d.)
