



## In-text Citation Examples

When citing sources in an APA style paper, APA uses the *author-date citation* system. In this system, the writer includes the author and date within the body of the paper and includes a corresponding reference in the reference list. This citation system allows the reader to identify sources used in the paper by reviewing the author and date within the text of the paper, and then easily locate the corresponding reference in the alphabetical reference list.

There are two types of in-text citations that can be used within the body of an APA paper to help the reader locate the corresponding reference in the reference list. The two types of in-text citations are *parenthetical citations* and *narrative citations*. A parenthetical citation is a type of citation where the author and date are listed at the end of the sentence in parentheses; whereas, the narrative citation identifies the author's name as part of the sentence with the date immediately following the author's name in parentheses.

There are a number of ways that parenthetical and narrative citations can be added to the body of the paper to aid in the readability and flow of the paper. The following table provides a few examples of common ways parenthetical and narrative citations are used for quotes and paraphrases.

Source with 2 authors in text.	Narrative Citation	List both authors in text. Separate the authors with the word "and". Add the date in parentheses immediately after the last name of the second author.	Smith and Lee (2019) located ...
Source with 2 authors in parentheses.	Parenthetical Citation	List both authors and date in parentheses. Separate with ampersand (&).	The authors proved the facts were true (Smith & Lee, 2019).
Source with no author in text.	Narrative Citation	Give the full title of the work in the text. Put the date in parentheses afterward. Italicize a book title, and use quotation marks if the work is an article.	The book, <i>Effective Management</i> (2019), illustrated ...  The article, "Effective Management" (2019), illustrated ...

More than one source with the same author’s last name in parentheses.	Parenthetical citation	Include the author’s last name, first initial, and date in parentheses.	(Smith, P., 2018)  (Smith, J., 2018)
General mention of website in text.	Parenthetical Citation	Add the URL in parentheses. Do not include a reference in the reference list.	We created our survey using Survey Monkey ( <a href="https://www.surveymonkey.com/">https://www.surveymonkey.com/</a> ).
Quote from website or electronic source with no page numbers with author’s name in text.	Narrative Citation	Include the author’s name in text. Add the date in parentheses immediately after the author’s last name. Add the paragraph number, heading or section, or both at the end of the quote in parentheses.	Smith (2019) argued “...” (para. 4).  Smith (2019) argued “...” (Emergencies section).  Smith (2019) argued “...” (Emergencies section, para. 4).
Quote from website or electronic source with no page numbers with author’s	Parenthetical Citation	Include the author’s name, the date, and the paragraph number, heading or section, or both in parentheses at the end of the sentence.
