



COVER PAGE FOR SUBMITTING L.E.A. LEGAL DEMANDS TO INTELIUQUENT

To facilitate the timely and orderly receipt, processing, and tracking of Legal Demands (see Sec. 1.1 of our LEA Guidelines) seeking customer-related information concerning telephone numbers, **a completed Cover Page must be submitted in addition to each Legal Demand.**

- **INSTRUCTIONS:** Please observe the following for use of this form, which is required for the submission via legal@inteliquent.com
- 1. DOWNLOAD** the cover page form. The form **cannot** be completed online (data entered online is **NOT** saved for transmission).
 - 2. COMPLETE** by typing into all fillable fields. A digital copy is required to access text entered on this form; **do NOT** handwrite.
 - 3. SAVE** the completed form as a digital file (**do NOT scan it** or consolidate in one file with the Legal Demand).
 - 4. ATTACH** the saved form to your submitting email as a **separate 2nd file along with** the Legal Demand and transmit your email.
 - 5. AGENCIES THAT MUST SERVE VIA US MAIL:** send your submitting email, then print our auto-reply email and include it with your mailing. Otherwise, if your agency **does not** require US Mail service, no further action is required beyond your email submission.

****REQUESTS TO INTELIUQUENT TO ESTABLISH A NEW WIRETAP / INTERCEPT:** As a wholesale provider, Inteliquent is generally not an optimal point for such arrangements (i.e., we typically do not carry all traffic relating to a number across our network; instead, you will want your probe established with our wholesale customer). If you have contacted us and it is determined that you should submit your intercept order to Inteliquent, the email subject line must include "NEW INTERCEPT REQUEST".**
